Beginning the 2013-2014 school year Grand Haven High School has partnered with the Ottawa County Sheriff's Office to have each vehicle receive a numbered parking sticker that will be displayed in the lower left portion of the windshield. This sticker will allow school officials quick access to vehicle owner/driver information and help with the security of our parking areas. The stickers will be provided from the Michigan Sheriffs' Association **STOPPED** program. In addition to providing an additional safety measure for the school district, the **STOPPED** program is a parental notification system that was developed for the state by the Michigan Sheriffs' Association. The goal of **STOPPED** is to reduce the number of young drivers who are injured or killed in motor vehicle crashes each year. If the driver of the vehicle, age 21 or under, is stopped by a deputy, the parents will be notified by letter of the circumstances surrounding the traffic stop, regardless of whether a citation is issued or not. The addition of the sticker will not increase the chances of the vehicle being stopped as the stickers are not observed until after the vehicle is stopped. If you were issued a **STOPPED** sticker in 2013-2014 school year, and still have the same vehicle on record you will not be issued another **STOPPED** sticker. Please enter that **STOPPED** sticker number in the blank above.

RULES FOR DRIVERS:

1. Operate the vehicle on school property in a safe and orderly manner. Reckless/careless driving or excessive speed will not be tolerated.
2. NO loitering, smoking or eating lunch in parked vehicles at ANY time. Vehicles are off limits during the school day, unless a pass is obtained from the main office.
3. Vehicles may not be parked in areas designated for STAFF/VISITORS or anywhere where parking is prohibited by law.
4. The school assumes no responsibility for damage or vandalism to vehicles/motorcycles parked on the districts property.
5. Vehicles parked on school property are subject to search as outlined in the student handbook.
6. Vehicles **MUST** have their issued numbered parking sticker displayed at all times.
7. Vehicles may be towed at the owners' expense for violation of the school parking policy.

I understand and agree to comply with the above rules. Parking at Grand Haven High School is a privilege. I understand that my permit to park at the school **MAY** be revoked and that I am liable for further disciplinary action if I violate **ANY** of the above rules.
