GRAND HAVEN AREA PUBLIC SCHOOLS BOARD OF EDUCATION Minutes - Regular Meeting February 8, 2016

The Board of Education met on Monday, February 8, at 7:00 p.m. at Rosy Mound Elementary School.

The meeting was called to order at 7:00 p.m. by President Siemion. The Pledge of Allegiance was recited.

The meeting agenda was approved as presented.

Rosy Mound Principal, Kevin Blanding, welcomed the board and recognized staff member Judy Wolffis who is retiring at the end of the school year.

Superintendent Andy Ingall shared a number of highlights related to the Core Values, including:

- Culture of Caring board members Seth Holt and Carl Treutler recognized GHHS graduates who recently passed away
- Excellence Leader in Me student program at Rosy Mound
- High Expectations board PD session held last week for self-assessment and growth
- Best Practice new desks and chairs will be ordered for the district
- Success for All multiple mental health efforts and initiatives throughout the community

Principal Blanding and parent Brian Pearson provided a report about the Watch D.O.G.S. (Dads of Great Students) program which increases parent involvement, particularly by an adult male in a student's life.

The board heard a quarterly report from Principal Jason Lawson on Lake Hills Elementary School, which is a requirement as a Focus School. Mr. Lawson shared what actions have been taken to raise achievement for all while accelerating achievement for the lower achieving students the fastest. Progress data was shared.

Becki Shackles, Director of Transportation, sought approval to purchase hardware and software to run a bus routing package called Transfinder.

16-015 Trustee Treutler moved that the board accept the proposal from Trivalent for \$29,117 to purchase Transfinder, a transportation routing software package, purchase to be made with bond funds.

Superintendent Ingall sought support for a resolution opposing Public Act 269, which prohibits governments from most forms of communication about ballot proposals within 60 days of an election.

Trustee Stack asked that the motion be amended to include language stating the new law allows privately funded people and corporations to gain a disproportionate voice.

Trustee Baker moved to amend the motion to include the new language.

Trustee Trueter seconded the motion. A roll call vote was taken: Stack, yes; O'Neal, yes; Holt, yes; Treutler, yes; Baker, yes; Siemion, yes.
