# Instructional Services

Mary Jane introduced Lakeshore Middle School Principal, Amanda Sorrelle

Lakeshore Middle School Principal Amanda Sorrelle provided updates on the school's progress on their school improvement goals. She reported that LMS was included in the top 40% in the state of Michigan in U.S. News rankings. Amanda shared various ways the school has updated their Positive Behavior System as well as efforts to grow student achievement through professional learning communities and instructional coaching. The school has also grown their system to provide targeted interventions to students through teacher instruction and iReady personalized instruction.
