Instructional Services

Mary Jane gave an update on Martin Luther King activities. Teachers, parents and administrators help plan and give feedback on activities that happened last week and today. Our purpose has always been to learn, serve and be inspired. An update on activities in the buildings along with volunteer opportunities was given. A district wide food drive to support Kids Food Basket collected 2000 items along with 2500 decorated bags. Approximately 10,000 items were collected to support Backpack Blessings, Hand2Hand and our high school pantries. Additionally we connected 149 secondary students to volunteer opportunities in our community today.

Griffin Elementary School Principal, Alex Harsay and Instructional Coach Kara Endsley showcased school improvement efforts with Griffin staff and students. They include an academic focus with collaborative teams, a book study of <u>Becoming A Better Grown Up</u> to grow the culture, a reading event that set a world record, collaboration with White Pines students, and other activities that build culture and connection and supports behavior systems.
