 - We are incredibly grateful for Mosaic's ongoing support in helping us meet the needs of our GHAPS students, staff, and families. Our partnership helps provide accessible mental health support to approximately 22 students throughout six buildings, bridging the gap and removing barriers for students and their families in receiving counseling services. Mosaic also provides GHAPS employees and their family members with access to an Employee Assistance Program, which includes a number of helpful resources including referral support and up to two free counseling sessions. We look forward to continuing our partnership with Mosaic Counseling to meet the needs of our students, staff, and families.
- Recognition of GHHS Varsity Tennis Coach, Chris Wilton for USTA 2024 Outstanding Facilities Award.

- o Grand Haven was one of only seven educational institutions from around the country to receive the award, while this award is a facilities award it is important to note that this award was received because of the quality and variety of programs offered and overall contributions to the game of tennis. Boys and girls varsity coach Chris Wilton, who has been connected to the Grand Haven tennis program for nearly 50 years, was in attendance for the recognition and attributed the program's success to the coaches, players, and parents.

Instructional Services

Lake Hills Principal Ian Overway and Instructional Coach Lyndsey Bensel shared the factors that contributed to their second National Blue Ribbon Award. Some established practices the staff has continued to lean into include collaboration, collective efficacy, data driven decision making, intentional and timely interventions, and purposeful instruction. Some new practices that contribute to their ongoing success include an increased emphasis on foundational reading skills, strengthening small group instruction, and differentiation with Bridges math. Professional learning remains foundational to student achievement. This year's focus for professional learning includes monthly shared learning with Bridges math, a clinic on math small groups, and a megalab on phonics instruction.

To facilitate the development and execution of a multi-year strategic plan, GHAPS issued a request for proposals (RFP) to qualified consulting firms. The district received and reviewed proposals from three consulting firms and conducted interviews with each to evaluate their alignment with GHAPS's strategic goals and their approach to stakeholder engagement, depth of planning, and demonstrated expertise in the educational sector. Following a thorough review, the recommendation is to engage Thru Consulting, LLC, a consulting firm, based on their experience, proposed approach, and alignment with GHAPS's vision. Thru has demonstrated a strong understanding of GHAPS's priorities and is equipped to provide both the strategic guidance and operational insights needed for a successful multi-year plan.

- Incredible opportunities and programs are available throughout our schools, but awareness is inconsistent.
- Many families and community members are missing important information and engagement opportunities because our communications infrastructure and systems are inadequate.
- We serve a growing population of students facing homelessness, poverty, language barriers, and
 other challenges that our community may not be aware of. Community partnerships are
 instrumental in helping us meet student needs and expand opportunities. Highlighting these
 partnerships can help our community understand the need and how they can further support our
 schools.
