GRAND HAVEN AREA PUBLIC SCHOOLS BOARD OF EDUCATION Meeting Minutes - Regular Board Meeting February 10, 2025

The Board of Education met on Monday, February 10, 2025, at 7:00 pm at Peach Plains Elementary. The

meeting was called to order at 7:00 pm by President, Nichol Stack. The Pledge of Allegiance was recited.

The following announcements were shared by Superintendent Perkowski:

- The Big Give and Community Cares for Teens were each recognized as February Grand Partner of the Month. Together, the two organizations supported more than 250 GHAPS students and their families over the holidays by providing gifts and basic needs.
- GHHS Student Senate was thanked for their tradition of using proceeds from their homecoming dance to fund gifts and needs for families as well. More than \$12k was raised to purchase gifts, which students then wrapped and delivered.
- Sarah Elliott was thanked for assisting these great organizations and for her hard work in supporting more than 300 homeless kids in our district.

Public Comment:

- Stephen Rockman read from a book.
- Oliver Shampine commented about diversity, equity and inclusion.
- Sarah Elliott commented about her work helping McKinney-Vento families in our district. Kate Hoffmeyer commented about the impact of 1:1 technology.

INSTRUCTIONAL SERVICES:

Mary Jane Evink introduced Peach Plains Principal Jason Lawson and staff for a school improvement presentation. Mr. Lawson and fourth grade teacher, Annie Ratke, spoke about a staff and parent book study of The Anxious Generation, which examines the impacts of technology use on children and proposes solutions. Instructional Coach, Jennifer Kenny, discussed peer to peer classroom visits as job embedded professional learning.

Mary Jane Evink reported on benchmark assessment data. Our goals are for 100% of K-8 students to experience growth in iReady testing with math and english language arts, and nearly all of our schools are showing high growth and proficiency. The goal for high school students is to be 100% on track for graduation. Mary Jane highlighted several specific areas of improvement and noted the strong growth that Ferry Elementary is celebrating this winter. Reasons for our growth might be attributed to teachers adjusting their instruction, instructional coaches delivering targeted professional learning to teachers, and the district providing better resources that are more closely aligned to state standards.
