- We have used five of our six snow days allotted this school year and may request an additional three days from the state if need be.
- Welcome to White Pines Intermediate School and thank you to Mike Shelton and staff for hosting this board meeting.
- In the Governor's state of the state address she mentioned a few initiatives regarding education. Those included:
 - Free all day preschool for all four year olds.
 - Recommending the continuation of free breakfast and lunch for all students
 - Two years of community college funding for all high school graduates.
- Welcome to Athletic Director Taylor Schriber along with representatives from the GHHS Girls Swim & Dive team. Coach Doug Thorne, along with team members Genevieve Springer, Emily Dixon, Claudia Busse, Rosalee Springer, and Grace Ackerman were present. They were undefeated in dual meets, won their 3rd straight conference championship, and finished runner-up in Division 1 at State. Coach Thorne was also named the MISCA Division 1 Coach of the Year. Congratulations on an outstanding season.

Instructional Services

Mary Jane introduced White Pines Intermediate School Principal, Mike Shelton

White Pines Intermediate School Principal Mike Shelton provided updates on the school's progress on their school improvement goals. This was a continuation of the work being done during PLCs that he presented to the board in October. Mike acknowledged the work of Jenny Shaughnessy, Assistant Principal along with Math and Instructional Coaches Katie Ingram, Laurel Pellegrom, Tiffany Severner and his entire staff. He shared various ways the school has grown student achievement through professional learning communities using an intervention tracker and intervention systems. Data is used to plan targeted interventions and to determine when students are ready to exit an intervention. Because of the continued, high quality work that WPIS is doing around PLC's, Solution Tree has invited them to apply to be a "Model PLC School".

Benchmark Assessment Scores - Mary Jane Evink provided the board with mid-year benchmark data using the iReady diagnostic and percent on track for graduation to show progress toward academic goals for K - 12 grade students. Data was disaggregated by grade levels and sub groups.

Trustee Eickholt moved to approve the contract with Skyward to implement and convert to their financial software. Total cost of implementation and year one will be \$165,456 (implementation & first year) with a subsequent annual recurring cost of \$48,766. We will spread the implementation cost over two fiscal years. This will be paid out of the General Fund.

17-609 Trustee Stack moved to approve the purchase of furniture for Special Ed elementary classrooms at a price of \$57,967.26. This will be a fiscal year 2023-24 purchase out of the capital projects fund 42.

17-610 Trustee Eickholt moved to approve the purchase of two convection steamers for the Food Service Department at a price of \$40,543.10 from Merchandise Equipment. This will be a fiscal year 2023-24 purchase out of the Food Service Fund.

17-611 Trustee Eickholt moved to approve the recommended, negotiated one-year Summer Tax Collection Agreements with Grand Haven Township, Spring Lake Township, City of Ferrysburg, City of Norton
