Instructional Services

Benchmark Assessment Scores - Mary Jane Evink provided the board with mid-year benchmark data using the iReady diagnostic and percent on track for graduation to show progress toward academic goals for K - 12 grade students. Data was disaggregated by grade levels and sub groups.

Central High School Principal, Kevin Berko and Amy Stringham, Math Teacher showcased the following:

- How Professional Learning Communities are executed slightly differently at Central High. In most subjects, there is only one teacher in this small school. This is referred to as a singleton. With no other teachers in like courses to collaborate with, the Central High staff collaborates around the life skills students need to be successful. These essential skills are identified, taught, and tracked by teachers.
- Shared additional strategies Central High uses to support students to be school ready.

Business Services
