## GRAND HAVEN AREA PUBLIC SCHOOLS BOARD OF EDUCATION Meeting Minutes - Regular Board Meeting February 7, 2022

The Board of Education met on Monday, February 7, 2022, at 7:00 p.m. at Central High School.

## Superintendent

Superintendent Grimes gave the board a review of COVID-19 Response-Masking Data and gave his recommendation to allow a masking optional policy as soon as February 22, 2022.

17-446 Trustee Baker moved to delegate to the superintendent's discretion to adjust our universal masking policy on February 28, 2022, pending a continued decline in school district cases and workforce availability.

## Instructional Services

Central High School Principal, Kevin Berko, shared progress on the school's improvement plans. As an alternative high school, this staff has collectively worked to improve attendance and graduation rates. Some features of programming that make them uniquely successful include:

17-447 Trustee Stack moved to approve the purchase and adoption of the K-12 Math resources as presented.

Mary Jane Evink, Executive Director of Business Services gave an update on benchmark assessments.

Districts are required to use benchmark assessments to measure progress toward academic goals. Goals were established in September, and public reporting happens at the first Board of Education meeting in February. This information is also found on the transparent page of our website.

Goals for elementary students are: 100% of students will show growth in reading and math. Students will score 40% or higher on Delta math benchmark in January.

Benchmark assessments: Benchmark Assessment System (BAS) for grades 1-4; DIBELS for K; Delta Math for K-4

Goals for students in grade 5-8 are: 100% of students will show growth in reading and math. Benchmark assessments: ELA Benchmark Assessment and Delta Math

Goal for students in grades 9-12: 100% of students will be on track for graduation

Measurement: Credits earned each semester
