The following announcements were shared by Superintendent Grimes:

- Superintendent Grimes welcomed and affirmed Lakeshore middle school for being rated the 32nd Middle School in the state and for their dedicated staff and hard work.
- The board was recognized for Board Appreciation Month and thanked for their commitment and dedication to our students, staff and community.
- An update was given on the upcoming change to isolation/quarantine guidelines from OCDPH.
- An update was given on the OSHA vaccination/testing requirement, more information to come on this topic.
- The OCDPH is starting to give vaccination data for various age groups. Superintendent Grimes announced that we are at nearly 42% of students aged 5-17 in our district that have been vaccinated.
- A statement was given that we have had our 8th day off due to various reasons and will be looking for flexibility from the state to forgive lost time and or any future time.

Public Comment: Twenty-four parents/ community members spoke regarding books in our libraries, safety, CRT, DEIB, and masking.

Instructional Services

Lakeshore Middle School Principal, Amanda Sorrelle, will describe the school improvement efforts to grow behaviors of Professional Learning Communities. Previously, staff worked on determining what all students need to learn at high levels, or what we call the essentials. The needs analysis this year determined they were ready to grow their practice in data collection and use of the data to deliver interventions. A common data wall was created and interventions are more widely practiced during the intervention block. Amanda will also show various ways students connect and give back to the community.

Mary Jane Evink, Executive Director of Instructional Services gave an informational update on Library Parent Controls and Materials Reconsideration Processes. Explained the various ways parents can be informed, involved, and limit what their children read if they choose.
