FACTORS USED IN REVISION:

- Pupil count of 4,986 (unaudited fall count)
- Staffing adjustments (interim dean at Rosy, additional staff at DSDC)
- Changes in retirement revenue (UAAL to State Aid, significant retirement offset decrease)
- 31a revenue increase of 25%
- Insurance rates increase (10%)
- Taxable value increase compared to proposed; increased property tax revenue
- Discretionary budget decrease

POTENTIAL ADDITIONAL/REDUCED REVENUES AND EXPENDITURES:

- Final pupil count
- Medicaid Revenue/Reimbursement
- Special Education/Act 18 funding
- Potential interest rate changes (locked in through the beginning of 2026, but anticipating rates to continue to come down)

RESOLUTION FOR ADOPTION BY THE BOARD
OF EDUCATION OF GRAND HAVEN AREA PUBLIC SCHOOLS
2025-26 BUDGET AMENDMENT #1

RESOLVED, that this resolution shall be the general appropriation of the Grand Haven Area Public Schools for the fiscal year 2025-26 a resolution to make appropriations; and to provide for the disposition of all income received by Grand Haven Area Public Schools.

BE IT FURTHER RESOLVED, that the total revenues and unappropriated fund balance estimated to be available for appropriation in the GENERAL FUND of Grand Haven Area Public Schools, for fiscal year 2025-26 is as follows:

BE IT FURTHER RESOLVED, that, to support the proposed budget for fiscal year 2025-26 the Grand Haven Area Public Schools shall levy its authorized millage rate of eighteen (18) mills of ad valorem property taxes on all property (excluding principal residence property and other property exempt by law) in order to generate the local revenue prescribed below; and that such millage, together with the district's other revenues, shall be used to support the expenditures prescribed below.

BE IT FURTHER RESOLVED, that **\$90,329,000** of the total available to appropriate in the GENERAL FUND hereby appropriated in the amount and for the purposes set forth below:

FURTHER RESOLVED, that no Board of Education member or employee of the School District shall expend any funds or obligate the expenditures of any funds except pursuant to appropriations made by the Board of Education and in keeping with the budgetary policy statement hitherto adopted by the Board. Changes in the amount appropriated by the Board shall require approval by the Board.

BE IT FURTHER RESOLVED, that the Superintendent is hereby charged with general supervision of the execution of the budgets adopted by the Board and shall hold the Principals, Directors, Supervisors and Department Heads accountable for the performance of their responsibilities within the amounts appropriated by the Board of Education and in keeping with the budgetary policy statement hitherto adopted by the Board.

BE IT FURTHER RESOLVED, that, for purposes of meeting emergency needs of the school district, changes in appropriations may be made upon the written authorization of the Superintendent. When the Superintendent makes a change in appropriations as permitted by this resolution, such change shall be presented to the Board of Education in the form of an appropriations act amendment, which shall be adopted by the Board of Education at a regularly scheduled meeting.

This appropriation resolution is to take effect immediately.
